# Specific hazards arising from the chemical

#### Methods and materials for containment and cleaning up

#### **Small spill**

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. # Appropriate engineering controls

Mineral Spirits 140-Flash
